With reference to the above, following clarifications are given in respect of payment of fee:

This is applicable only for the students of:

- B.E./B.Tech. admitted during 2006-07, 2007-08, 2008-09, 2009-10 (both regular & lateral entry) and 2010-11 (only lateral entry)
- B.Arch. admitted during 2006-07
- MBA/M.Tech. admitted during 2009 2010, 2010 2011, 2011-2012 and 2012-2013
- MCA admitted during 2009 2010 and 2010 2011
- 1. For the students who have approached the Court of law and have attended examinations and their results are still pending:
 - > The students need to approach their respective colleges
 - > Colleges shall take a request letter from the students to announce their results
 - > Collect a fee of Rs.2000/- per subject (maximum of Rs.6000/- per semester)

- > Forward the students request letter to the Registrar (Evaluation), VTU Belagavi, with the following documents:
 - ✓ students request letters
 - ✓ Details of the examination/subject he/she has appeared and results awaited by mentioning month and year of appearance.
 - ✓ Demand Draft drawn in favour of Finance Officer VTU Belagavi, for the fees paid.
- 2. For the students who are admitted under the benefit of notification ref (3) above:
 - 1. Such students shall submit the online examination application forms at their respective colleges
 - 2. The examination fees for students is Rs.2000/- per subject (maximum of Rs.6000/- per semester).
- 3. Internal Assessment Marks in respect of students who have approached the Court of law and have attended the examinations and are awaiting for their results:
 - The colleges shall forward the Internal Assessment Marks to the office of the Registrar (Evaluation), if tests are conducted
 - If the tests are not conducted, the colleges shall conduct IA tests as per the norms and submit the IA marks expeditiously.
- 4. Internal Assessment Marks in respect of students who are admitted under the benefit of notification ref (3) above as per prevailing procedures.

All other clauses of ref (3) - VTU/Aca/2016-17/5659 dt: 27-10-2016 remain the same.
