CIRCULAR

**Sub: Applicability of University Notification VTU/PS/Exam
/2015 -16/988, dated 14.09.2015 – reg.**

**Ref: Notification No. VTU/PS/Exam/2015-16/988, dated
-14.09.2015.**

This is to bring to the notice of the Principals of all the affiliated colleges that, the Executive Council of VTU through its resolution No.8.2 dated 29-09-2015 has resolved to adhere to the existing Rules and Regulations of the University pertaining to maximum duration of Undergraduate and Postgraduate courses and not to grant any further extension to the students to complete the course. Further, the Hon'ble High Court of Karnataka upheld the University Regulations in respect of Maximum Duration and dismissed writ petitions (2252/2016 and connected cases) in respect of the same.

In light of the above, the permission granted to the students (Notification No. VTU/PS/Exam/2015-16/988, dated 14.09.2015) who have completed their course duration to appear for the Dec.2015/Jan 2016 and May/June/July 2016 examinations *is restricted to Dec. 2015/Jan 2016 Examinations only. Further, the said notification is NOT APPLICABLE TO the Examinations to be conducted during MAY/JUNE/JULY 2016.*

Further, all the Principal of respective affiliated colleges are directed to strictly adhere to and follow the eligibility criteria prescribed in the University Regulations OB 6.2 before admitting students for the courses. In the event of any doubts, the Principal shall consult the University for Clarification with respect to the admission as well as eligibility criteria. The willful omission of adhering to the University Regulations will make the Principal of respective colleges responsible to answer to the court of law and the University will not take any responsibility in this behalf.

The Principals of the colleges affiliated to VTU are hereby directed NOT TO PERMIT any student who have completed the maximum duration of the course to attend the classes and also not to allow them to fill the examination forms. It is the responsibility of the Principals of the respective colleges to keep their students aware of the University regulations regularly and advice them accordingly.
