 - a. Application Fee Rs. 20/- per candidate,
 - b. Examination Fee Rs. 1500/- for Regular semester irrespective of number of subjects and
 - c. Arrear Examination Fee Rs.300/- per subject for arrear semester to the maximum of Rs.1200/- per semester
 - d. Marks Card fee Rs.75/- per semester
3. **Submission of Consolidated list and Fee to the University:** The college shall take a report after the last date and submit the fee to the University through **online Fee Payment** option available at <http://vtu.ac.in/online-fee-payment/>. After making payment, receipt, report and consolidated list shall be submitted to the office of the undersigned on or before 10th January 2018.
