4. Use Departmental login Id and password to login

6. Fee for Revaluation is Rs. 400/- per subject and for Photocopy is Rs.300/- per subject and Application Fee of Rs.20/- per candidate.
7. All the students are eligible to apply for Revaluation in any number of theory subjects.
8. All the students are eligible to apply for Photocopy of answer scripts in any number of theory subjects (**excluding the scripts attached with drawing sheets**).


1. **The students should not apply for photo copy in the subjects**
