1) Eligibility Criteria:-

A) Statutory Requirements:-

1. The Tenderer should furnish GST Registration Certificate.
2. The Tender should have registered with Municipal Corporation/Registration of Societies/Companies/Director of industries and principal place of business of the Company or firm or partnership, as the case may be.
3. IT returns for the past 3 years (Assessment year-2015-16, 2016-17 & 2017-18) and VAT returns for financial years 2014-15, 2015-16 & 2016-17.

B) Technical requirements:-

At least 03 years experience / expertise in the successful execution of similar works tendered and the cost of such works should be not less than 80% of estimated amount in any State Central Govt. or Quasi Govt. Dept. of Undertaking/Universities, Engg. Colleges etc.
