##### **A) Statutory Requirements:**

3. IT returns for the past 3 years (Financial year – 2015-16, 2016-17 & 2017-18) and GST / VAT returns for 2015-16, 2016-17 & 2017-18.
4. Authorization letter from OEM.

##### **B) Technical requirements:**

- a) At least 3 years experience / expertise in the successful execution of supply of similar tendered and the cost of such supplies should not be less than 80% estimated amount in any State Central Govt. or Quasi Govt. Dept. or Undertaking / Universities (Purchase orders).
