A) Statutory Requirements:

3. PAN Card Photocopy.
4. IT returns for the past 3 years (Financial year – 2015-16, 2016-17 & 2017-18) and GST / VAT returns for 2015-16, 2016-17 & 2017-18.

B) Technical requirements:
