1) Eligibility Criteria:

A. Statutory Requirements:

- IT returns for the past 3 years (Assessment year – 2015-16, 2016-17 & 2017-18)) and GST / VAT returns for the financial year 2014-15, 2015-16 and 2016-17.

B. Technical requirements:

- At least 3 years of experience/expertise in the successful execution of similar works tendered and the cost of such any one work should not be less than 30% of estimated amount in a single tender in any State Central Governments of Quasi Government Department of Undertaking /Universities/Colleges /Schools recognized by Government of Karnataka.
