2.1: Affiliation Matters

Item No.2.1.1 of the Agenda of 163rd meeting of the Executive Council to be held on 4th January 2022

ADDITION OF CLAUSE REGULATIONS GOVERNING CHANGE OF COLLEGE AND CHANGE OF BRANCH

The Regulations Governing Change of College and Change of Branch at VTU, have been approved by the Executive Council in its meeting held on 27-05-2020 under Res.No.2.1.5.

During the process of approval for change of college and change of branch, the proposals have been received from few institutes where:

- (a). the college has closed / progressively closing a branch and only students admitted under Supernumerary Quota (SNQ) were left in the said branch
- (b). only 10 or less than 10 students were left in the branch which is closed / getting closed.

The Hon'ble Vice Chancellor constituted a Committee under the Chairmanship of Shri Jitendra P.Nayak, to review and recommend in the said matter. The Committee met on 03-12-2021 to deliberate on the subject and submitted its recommendations (copy enclosed).

Accordingly, the following clauses may be added /amended in the existing Regulations governing Change of College and Change of Branch:

Amendment to Regulations Governing Change of College:

COC 3 (iii) (c)	Addition of clause: The College may issue No Objection Certificate for students admitted under Supernumerary Quota (SNQ), only if the branch to which the student is admitted is closed / progressively closing
COC 3 (iii) (d)	Addition of clause: The College may issue No Objection Certificate for student/s of a branch where strength is less than 10, only if the branch to which the student is admitted is closed / progressively closing.

Amendment to Regulations Governing Change of Branch:

COB 3 (7)(b)	Addition of sub-provision to the existing clause 3(7)(b): However, students admitted under Supernumerary Quota (SNQ), may apply for Change of Branch only if the branch to which the student is admitted is closed / progressively closing.

COB 3 (7)(g)	<p>Addition of sub clause after 3(7)(f):</p> <p>The student/s from the branch, where strength is less than 10, may apply for change of branch, only if the branch to which the student/s is admitted is closed / progressively closing.</p>

In view of urgency, the above mentioned provisions have been notified and were implemented, Now, the subject is placed before the Executive Council for consideration and ratification of the action taken.

COC 3 (iii) (d)	<p>Addition of clause:</p> <p>The College may issue No Objection Certificate for all the students of a branch where strength is less than 10, only if the branch to which the student is admitted is closed / progressively closing in that institute.</p>

Amendment to Regulations Governing Change of Branch:

COB 3 (7)(g)	<p>Addition of sub clause after 3(7)(f):</p> <p>The student/s from the branch, where strength is less than 10, all of them may apply for change of branch, only if the branch to which the students admitted is closed / progressively closing in that institute.</p>

RELAXATION IN VERTICAL PROGRESSION
NORMS FOR PG STUDENTS OF VTU FROM
2021-22 AND ONWARDS

The Executive Council vide Res.No.2.1.2, of the 162nd meeting held on 30-10-2021, has resolved to grant relaxation with regard to the applicable vertical progression norms, subject to the maximum duration, for the students of B.E./ B.Tech./B.Arch./B.Plan., registered under 2015, 2017 and 2018 schemes.

In light of the same, the norms of the vertical progression for the Post Graduate students, admitted under following schemes, may be relaxed, subject to the maximum duration of the programme:

CONSIDERATION OF ACADEMIC CALENDAR
FOR LATERAL ENTRY STUDENTS (3RD SEM.)
FOR THE ACADEMIC YEAR 2021-22

Academic Calendar 3rd semester B.E./ B.Tech. has been notified as mentioned below:

Commencement date	:	18.10.2021
Last working date	:	19.02.2022
Examination duration (Practical & Theory):	:	21.02.2022 to 25.03.2022
Commencement of 4 th semester	:	11.04.2022

It has been noted that all most all the diploma lateral entry students are joining the course after the laps of 58 working days (18-10-2021 to 30-12-2021) and working days available for these students are 41 days with 06 Sundays and 02 holidays (30-12-2021 to 19-02-2022) . The examination duration is 28 working days (21-02-2022 to 25-03-2022).

Keeping in view the above facts, the following changes are proposed for lateral entry students:

- a. If 3rd semester examination dates may be postponed and conducted in the middle of 4th sem., with provision of additional 30 working days in academic calendar(one week for preparation and 24 days for examination), so that the academic activities for lateral entry students can be completed satisfactorily.

OR

- b. The 3rd sem. examination may be conducted from 28-03-2022 and 4th sem. can be commenced after the examination. With this also 69 working days and 12 Sundays will be available for lateral entry students to complete all the academic activities.

The subject is placed before the Executive Council for consideration and approval.

Resolution No.2.1.4

The Executive Council resolved to accept the recommendations of the Academic Senate which recommended following Academic Calendar for the Lateral Entry Students(3rd sem.) admitted during the academic year 2021-2022, to complete the academic activities:

- i. To provide 60 working days for these students and to conduct the 3rd sem. Examination from 28-03-2022**
- ii. The classes of 4th Semester for these students shall commence after the examination**

The Executive Council resolved to accept the recommendations of the Academic Senate to conduct separate classes for the Lateral Entry Students of the above said batch in each of the colleges.

CONSIDERATION OF THE REQUEST OF LATERAL
ENTRY STUDENTS WITH BACKLOG SUBJECT/S OF
BRIDGE COURSES TO COMPLETE THEIR DEGREE

The students who seek admission to 3rd semester B.E./B.Tech. programmes under Lateral Entry category, have to study and pass the bridge courses (Advanced Mathematics I / II). There are some students who could not clear these bridge courses even after several attempts and are not eligible to get their degree.

Many of such students have approached AICTE and UGC requesting to waive off these courses and to award the degree. The AICTE (vide letter No.AICTE/AB/SWR/CMRIT/2021, dt:08-11-2021) and UGC (vide letter F.No.2-44/Complaints/UGC-SWRO/2021, dt:29-09-2021) have requested the University to look into the matter and to consider their request.

The subject was discussed in the meeting of the Special Committee, and Committee was of the view that awarding the degree without examination may not be proper and recommended as under:

- i. Two additional examinations (attempts) only to clear the pending Bridge Courses may be provided for all batches of Lateral Entry students who have got admission to the said programme till 2013-14. These additional attempts may be granted only for those students who have cleared all the other subjects and have completed rest of the programme requirements except the Bridge Courses.
- ii. Six months advance Notification may be issued to the knowledge of the students to know the opportunity provided and to take the benefit out of it.
- iii. The question paper pattern may be redesigned and notified well in advance with model question papers and the Registrar(Eval.) may plan in this regard.

The subject is placed before the Executive Council for consideration and further direction. The subject has been placed before the Academic Senate and the recommendations of the Academic Senate is placed on the table.

Resolution No.2.1.5

The Executive Council resolved to accept the opinion of the Academic Senate that awarding the degree without examination to the Lateral Entry Students with Backlog subject/s of Bridge Courses, may not be appropriate. Further, the Executive Council resolved to accept the recommendations of the Academic Senate which recommended to accept the following:

- i. To grant Two additional examinations (attempts), only to clear the pending Bridge Courses, for all batches of Lateral Entry students who have got admission to the said programme till 2013-14. These additional attempts shall be granted only for those students who have cleared all the other subjects and have completed rest of the programme requirements except the Bridge Courses.**
- ii. Six months advance Notification shall be issued to the knowledge of the students to know the opportunity provided and to take the benefit out of it.**
- iii. The question paper pattern may be redesigned and notified well in advance with three model question papers and the Registrar(Eval.) may plan in this regard.**
- iv. The possibility of having a common syllabus for all the batches be explored by the concerned BOS.**

The Executive Council further resolved to accept the recommendations of the Academic Senate to assist the students through online lectures at e-learning platform and conduct the less stressed examination with open choice system for these students.

CONSIDERATION OF THE RECOMMENDATIONS OF LIC –
SHREE VINAYAKA INSTITUTE OF TECH., KGF &
SRI BASAVESHWARA INSTITUTE OF TECH., TIPTUR

Shree Vinayaka Institute of Technology, KGF, Kolar, had not applied for affiliation during the process of online submission of affiliation application for the academic year 2021-22. Now, the College has requested the University for the grant of affiliation for the year 2021-22.

A Penalty of Rs.1 lakh has been imposed on the erring College and the Hon'ble Vice Chancellor constituted the Local Inquiry Committee to inspect the College and normalise the affiliation process. The Committee has inspected the College and submitted the report.

In another case, earlier the Local Inquiry Committee which visited Sri Basaveshwara Institute of Technology, Tiptur, had recommended for 'zero' intake for all the courses offered by the College for the academic year 2021-22. On the request of the College, the Hon'ble Vice Chancellor recommended for the revisit of the College by LIC. The Committee has inspected the College once again, and submitted its report.

The subject is placed before the Executive Council, along with the LIC reports of both the colleges, for consideration and further directions.

The subject has been placed before the Academic Senate and the recommendations of the Academic Senate is placed on the table.

Resolution No.2.1.6

APPROVAL FOR THE ELIGIBILITY CRITERIA FOR M.PLAN (SMART CITY PLANNING) PROGRAMME

Starting of M.Plan. programme in Smart City Planning and Scheme of Teaching and Examination are approved by the Executive Council in its 156th meeting held on 16-03-2021, under Res.No.2.2.1.

The Eligibility for admission to the said programme as mentioned in the Regulation governing M.Plan(SCP) is as under”

*Admission to the Master of Planning (Smart City Planning), Programme shall be open to all the candidates who have passed **B. Plan or B.Arch or B.E / B.Tech in Civil Engineering/ Building Technology/ Construction Technology/ Environmental Engineering or M.A/M.Sc (Geography)** (as per the eligibility criteria specified from time to time) of VTU or any other recognized University / Institution. The decision of the Equivalence committee shall be final in establishing the eligibility of candidates for a particular Programme.*

For the foreign degrees Equivalence certificate from the Association of Indian Universities is a must.

However, the candidates who have completed their prerequisite degree through the distance mode education are not eligible for admission to M. Plan.(SCP) Programs under any quota incl.Govt./Management.
