The Standing Committee has made certain observations and recommended not to forward the applications of above referred two colleges who have applied for grant of Autonomous Status, to UGC.

# CONSIDERATION OF THE DIFFERENCE IN PERIOD OF GRANT OF AUTONOMOUS STATUS TO DAYANAND SAGAR COLLEGE OF ENGINEERING, BANGALORE, BASED ON UGC LETTER

The Autonomous Status has been granted to Dayanand Sagar College of Engineering, Bangalore, for the period of six years from 2015-16 to 2020-21, vide University Notification No.VTU/Aca/2014-15/A-11/2354, dt:01-07-2015, with the approval of the State Govt. and subject to the approval of University Grants Commission, New Delhi.

However, the UGC, New Delhi conferred the Autonomous Status on the said College for six years w.e.f. 2017-18 to 2022-23, vide letter No.F.22-1/2017(AC), dt:06-04-2017.

VTU has written to the said College to submit the UGC approval for Autonomous Status for the years 2015-16 and 2016-17. It has also written letter to the UGC seeking clarification for the difference in period of grant of Autonomous Status to the said College. However, no reply has been received.

The College is requesting the University to condone the delay and to grant the Autonomous Status for the years 2015-16 and 2016-17 also. To match with the period of grant of Autonomous Status by VTU to the said College in line with the period of Autonomy granted by UGC, the VTU wrote letter to the Government for grant of Autonomous Status to the College for further years 2021-22 and 2022-23. The State Government has approved the same vide its letter No. ED8TEC 2022, dt:05-03-2022.

Hence, the matter is placed before the Executive Council, along with necessary documents, for consideration and directions to issue Notification accordingly to the College granting Autonomous Status for the years 2021-22 and 2022-23 also.

The subject is placed before the Academic Senate and the recommendation of the Academic Senate will be placed on the table.

# CONSIDERATION OF DRAFT GUIDELINES AND NORMS OF VTU FOR IMPLEMENTATION OF ACADEMIC AUTONOMY IN INSTITUTIONS (2018) AMENDMENT IN 2022, EFFECTIVE FROM 2021-22

The Guidelines and Norms for Implementation of Academic Autonomy to affiliated institutions of VTU, were framed and amended in the 2018. Keeping in view the latest Regulations of UGC / AICTE, circulated during the year 2021, amendments to these Guidelines and Norms have been felt necessary.

Adverting to the above, a Committee under the Chairmanship of Dr. V. B. Coutinho, Hon'ble Member of the Academic Senate of VTU and former Vice Chancellor of Gulbarga University, has been constituted to study the revised rules and regulations of UGC and AICTE in this regard and draft the revised Guidelines and Norms for Implementation of Academic Autonomy.

Accordingly, the Committee met on 15<sup>th</sup> March 2022, deliberated on the subject and submitted the draft "Guidelines and Norms for Implementation of Academic Autonomy in Institutions (2018) Amendments in 2022", applicable from the academic year 2021-22. The same has been circulated to the Autonomous Colleges under VTU for their feedback. These Guidelines and Norms have been discussed in the meetings of the Principals of Autonomous Colleges held on 7<sup>th</sup> April 2022. The suggestions and feedbacks received, have been incorporated in the said draft Guidelines and Norms.

Now, the draft of "Guidelines and Norms for Implementation of Academic Autonomy in Institutions (2018) Amendments in 2022", to be effective from the academic year 2021-22, is placed before the Executive Council for consideration and approval.

The subject is placed before the Academic Senate and the recommendations of the Academic Senate is placed on the table.

CHANGE OF NAME OF S L. N. COLLEGE OF ENGINEERING, RAICHUR

- The Government has allotted land TO the H. K. E. Society in 2006 to start the Technical College. Accordingly the Society has started Engineering College at Raichur naming it as "H. K. E. Society's S.L.N. College of Engineering, Raichur". Further, the Society has asked for additional land for education purpose to the Government and in response the Government has allotted additional land in Raichur with a direction to name the College as "H.K.E. Society's Sir M. Visvesvaraya College of Engineering, Raichur".
- Now, the President of the Society has submitted its request along with Government Orders, vide letter dated 09-04-2022, to change the name of the College from "H. K. E. Society's S.L.N. College of Engineering, Raichur" as "H.K.E. Society's Sir M. Visvesvaraya College of Engineering, Raichur".
- The subject is placed before the Executive Council for consideration and necessary approval.

#### Resolution No.2.1.5

The Executive Council resolved to approve to change the name of the College from "H.K.E. Society's S.L.N. College of Engineering, Raichur" to "H.K.E. Society's Sir M. Visvesvaraya College of Engineering, Raichur", following VTU norms.

CONSIDERATION OF ADDITION OF CLAUSE TO 210B14: VERTICAL PROGRESSION IN THE REGULATIONS GOVERNING THE B.E. / B.TECH. / B.PLAN. / B.ARCH. / B.SC. (2021)

Taking into consideration the inputs from the stakeholders w.r.t. the existing Vertical Progression Clause 21OB14.0, under the University Regulations governing the B.E./B.Tech./B.Plan./B.Arch./B.Sc. (2021) Programs, it is felt necessary to add the following additional Clause to 21OB14.0:

21OB14.1: All the below clauses are subject to maximum duration of eight years (for Regular Students) / six years (for Lateral Entry Students), as applicable.

# 1) In case of students admitted to the first year:

- (a) Students have to fulfill the attendance and CIE requirement to appear for SEE of course/s of first year (1<sup>st</sup> and 2<sup>nd</sup> semester) (Refer to clause No.21OB5.4)
- (b) Students having not more than four 'F' grades in the 1<sup>st</sup> and 2<sup>nd</sup> semesters of first year of the program, shall be eligible to move to the 3<sup>rd</sup> semester(second year) of the program. These courses include courses marked as NE as per clause No.21OB12.2.
- (c) The students who fail to satisfy CIE and attendance requirement, have to repeat the courses whenever offered next and become eligible for the second year. (Refer to clause No.210B9.9 and 210B5.1)

The subject is placed before the Executive Council for consideration and approval.

- 1) In case of students admitted to the first year:
  - (a) Students have to fulfill the attendance and CIE requirement to appear for SEE of course/s of first year (1<sup>st</sup> and 2<sup>nd</sup> semester) (Refer to clause No.210B5.4)
  - (b) Students having not more than four 'F' grades in the courses of 1<sup>st</sup> and 2<sup>nd</sup> semesters of first year of the program, shall be eligible to move to the 3<sup>rd</sup> semester(second year) of the program. These courses include courses marked as NE as per clause No.210B12.2.
  - (c) The students who fail to satisfy CIE and attendance requirement, have to repeat the courses whenever offered next and become eligible for the second year. (Refer to clause No.210B9.9 and 210B5.1)"

As per Clause 19JYDF 3.0(ii): "The Fellowship is applicable to only those Researchers who pursue Research programme on fulltime at any of the Post-Graduate Departments of University PG Centers located at Belagavi, Kalaburagi, Muddenahalli and Mysuru."

However, the University has one Constituent College UBDT College of Engineering, Davangere, which may be included in the scope of VTU Jnana Yaana Doctoral Fellowship Scheme, and the said Fellowship may be provided to the eligible Research Scholars at the Departments of this College also.
