CONDUCTING ANNUAL INSPECTIONS OF THE AFFILIATED ENGINEERING COLLEGES, SCHOOLS OF ARCHITECTURE, AND RESEARCH CENTERS UNDER VTU, FOR THE ACADEMIC YEAR 2022-23

As discussed previously, the annual inspections of affiliated engineering and architecture colleges of VTU, for granting Temporary / Permanent affiliation, Autonomous status and also for starting new colleges / new courses/ variation of intake / continuation / extension of affiliation, and recognition / extension of recognition of Research Centers, for the academic year 2022-23, have been conducted.

The action of the Hon'ble Vice Chancellor for constituting various Local Inquiry Committees for conducting the said inspections, has been placed before the Executive Council for ratification.

The subject is being placed before the Academic Senate and the recommendation of the Academic Senate will be placed on the table.

#### APPROVAL FOR THE PROGRESSIVE DISAFFILIATION OF SJM INSTITUTE OF TECHNOLOGY, CHITRADURGA, FROM VTU

The Registrar of Sri Jagadguru Murugharajendra University, Chitradurga, vide letter dt:02/06-07-2022, has requested the University to disaffiliate the SJM Institute of Technology, Chitradurga, from VTU system progressively w.e.f. the academic year 2022-23, as per the decision of SJM Vidyapeetha, to align the said College as an off-campus / constituent college of Sri Jagadguru Murugharajendra University.

The Government vide Notification EO.No.ED/120/URC/2021, dt:13-06-2022, has accorded approval to commence as a Private University namely Sri Jagadguru Murugharajendra University, Chitradurga.

The subject along with a letter received from the Registrar, Sri Jagadguru Murugharajendra University, Chitradurga, and the Government Notification, is placed before the Executive Council for consideration and approval for progressive disaffiliation of the College, with the conditions:

- a) To inform heads of the concerned sections to verify dues if any and to continuously monitor and collect the University fees from the college till the closure of last batch.
- b) To inform heads of the concerned sections to consider the same while sanctioning research grants, registration of Ph.D. scholars etc.

The subject is being placed before the Academic Senate and the recommendation of the Academic Senate will be placed on the table.

#### CONSIDERATION OF THE RENEWAL OF MOU WITH AIR FORCE TECHNICAL COLLEGE TO OFFER PGDAE, AND REQUEST FOR DISCONTINUATION OF M.TECH IN AERONAUTICAL ENGINEERING

The Air Force Technical College(AFTC), Bangalore, Extension Centre under VTU, offers Post Graduate Diploma in Aeronautical Engineering (PGDAE) and has started M.Tech. in Aeronautical Engineering programme, during the academic year 2021-22.

Now, the Group Captain / Chief Instructor of AFTC, vide his letter No. AFTC/1819/2/Trg(BM II), dt:09-07-2022, has requested to discontinue the M.Tech. programme from the academic year 2022-23, and no further registration to be made for this programme. However, the first batch will complete the course.

Further, Air Force Technical College, has also requested to renew its Memorandum of Understanding (MoU) with VTU, the validity of which is expiring on 31-03-2022, to conduct the PG Diploma in Aeronautical Engineering.

Hence, the matter is placed before the Executive Council for consideration and further approval:

- i. To discontinue the M.Tech. in Aeronautical Engineering programme w.e.f. 2022-23
- ii. Permit to conduct classes for the candidates admitted during A.Y. 2021-22, till the completion of the course
- iii. To renew the MoU to conduct PGDAE, for a further period of five years.

The subject is placed before the Academic Senate and the recommendations of the Academic Senate will be placed on the table.

#### Resolution No.2.1.3

The Local Inquiry Committees have been constituted and physical inspections of these colleges have been conducted.

The Inspection Reports of the colleges listed below have been placed before the LIC Reports Review Committee(LIC RRC), in its meeting organised on 22-07-2022 and 28-07-2022 in the VTU Head Quarters and the recommendations of the LIC RRC have been placed on the table.

This list includes some of the colleges for which still AICTE approval letters have not been received.

#### Resolution No.2.1.4

The Executive Council resolved to accept the recommendations of the Academic Senate which recommended to accept the LIC Report Review Committee(LIC RRC) recommendations, for the academic year 2022-23, w.r.t.:

- *i.* 194 engineering / architecture colleges inspected for continuation of Temporary affiliation
- *ii.* 04 new Engineering / Architecture Colleges
- *iii.* 10 Colleges inspected for grant of Permanent Affiliation

*Further, the Executive Council resolved to accept the recommendations of the Academic Senate which recommended to accept the recommendation of the LIC RRC to* 

- i. issue warning letter to 15 listed colleges, as serious observations have been made by LIC against them and to conduct mid-term re-inspection during this academic year, for these colleges. If these colleges do not comply the deficiencies during the mid-term inspection (which will be conducted after 06 months), the grant of affiliation for 2023-24 will be affected adversely. (List enclosed)
- ii. 'zero' intake for first year admission for listed 04 colleges (List enclosed)

Further, the Executive Council also resolved to accept the recommendation of the Academic Senate, which recommended to authorise the Hon'ble Vice Chancellor, to accept the LIC recommendations for the Engineering / Architecture Colleges for whom Approval letter from AICTE or from Council of Architecture, is still awaited.

*The Executive Council resolved to adopt following guidelines for the academic year 2022-23, w.r.t. grant of affiliation:* 

- i. Colleges who have performed good in previous years and the LIC while inspecting, has not observed any grave deficiencies in them, for such institutions VTU shall consider AICTE recommended intake, new courses and variation in intake.
- *ii.* Further, if such institutions have recruited teachers recently, for increased intake or introduction of new courses, the same shall be accepted at VTU. However, such teachers must comply the norms of the University with reference to TAAS.
- iii. It has been observed that few institutions have got approval from AICTE for Variation in intake, but have not applied to VTU, for the same. It shall be considered for the academic year 2022-23, however, the colleges must get these intakes ratified by applying to the University with requisite fees and shall be inspected during the next LIC.
- iv. For the Colleges who have got approval for intake from AICTE, but VTU LIC has observed deficiency in the said Colleges and reduced the intake. In such cases, the recommendation of LIC RRC, approved by the Executive Council will be binding.

#### CONSIDERATION OF EXTENSION OF AUTONOMY PERIOD FOR PDACE, KALABURAGI AND BEC, BAGALKOT

The PDA College of Engineering, Kalaburagi and Basaveshwar Engineering College, Bagalkot, have applied for the extension of Autonomous Status from the year 2019-20.

VTU has recommended for the extension of Autonomous Status to these colleges subject to the approval from UGC and forwarded their applications to UGC. However, till date these colleges have not received approval for extension of Autonomous Status from UGC. Further, these colleges have admitted the students under Autonomous scheme during the years 2019-20, 2020-21 and 2021-22.

University has sent letters to these colleges directing them to obtain the extension of Autonomous Status, Further, the validity period of NBA accreditation for PDACE, Kalaburagi, has expired on 30-06-2022 and validity period of NAAC accreditation for BEC, Bagalkot will be over by 26-11-2022.

As the State Government admission process for the year 2022-23 have been started, the subject is placed before the Executive Council for consideration and further directions, with regard to the Autonomous Status of these colleges.

The subject is placed before the Academic Senate and the recommendations of the Academic Senate will be placed on the table.

#### Resolution No.2.1.5

#### **Resolution No.2.2.1**

The Executive Council resolved to accept the recommendation of the Academic Senate which accepted to incorporate the directions received from National Quality Frame Work of UGC which recommended to have minimum 80 credits to M.Tech. and M.Plan. programmes for the Award of PG Degree.

Further, the Executive Council resolved to accept the recommendations of the Academic Senate which recommended to approve two different sets of curriculum for University PG Programmes and for the affiliated college PG Programme.

Further, the Executive Council resolved to accept the recommendation of the Academic Senate which recommended for the introduction of M.Tech. Programme with following three options to the candidate:

- i. There will be an exit option for the students after completing one year (40 credits) and get PG Diploma Degree. Such students may join back to the programme after one year gap(with industry / professional experience) and continue to complete one more year and earn a total of 80 credits for the award of M.Tech. Degree. Such students will possess both the degrees, viz, PG Diploma and M.Tech.
- *ii.* Regular M.Tech. Programmes of two years
- *iii.* Here M.Tech. programme will be offered in two ways:
  - (a) M.Tech. (Research) wherein the student will be completing coursework in first two semester and the dissertation with quality research work in next two. The student may continue further as a part of Integrated Ph.D. Programme.
  - (b) M.Tech. wherein three semester of course work followed by the final semester of Project

The Chairman expressed that a Detailed Regulation for these programmes will be brought out by VTU

#### Section – 6 INFORMATION ITEMS

#### Item No. 6.1 NAAC Accreditation to VTU

The Chairman informed the members that, the University has successfully completed the first cycle of NAAC Assessment and received B+ grade. He also informed that, after a year or so, University could apply for reassessment and get the grade improved.

#### Item No. 6.2 NIRF Ranking to VTU

The Chairman expressed his happiness informing the positions secured by VTU in the NIRF Ranking for the year 2022, as announced by Ministry of Education, Govt. of India, New Delhi, on 15<sup>th</sup> July 2022:

Overall Category : 100<sup>th</sup> place University Category: 72<sup>nd</sup> Rank Engineering Category : 49<sup>th</sup> Rank Management Category : 76<sup>th</sup> Rank

The Chairman expressed that the progress has been achieved in rankings as compared to the ranks secured during the previous year.

He also expressed that now VTU is eligible to apply for "Institute of Eminence" by UGC.

#### Item No. 6.3 Inauguration of ATAL IDEA Lab

The Chairman informed the members that ATAL IDEA Lab which has been established with the Financial assistance of AICTE, at VTU Campus, Muddenahalli, is being inaugurated on 3<sup>rd</sup> August 2022. The AICTE Chairman will be the Chief Guest for the Inaugural Programme. The Chairman requested the members to be present for the programme. This will be a largest Model IDEA Lab in entire South India. Series of FDP are being conducted here.

#### Item No. 6.4 Har Ghar Tiranga

The Chairman informed that on the occasion of 75<sup>th</sup> year celebration of Independence, information has been received from the UGC to hoist the Tiranga Flag on every house. University will write to colleges to follow the same and also, this will be followed across all the campuses of VTU, including Belagavi Head Quarters.

#### Item No. 6.5 Exhibition hosted at VTU with the assistance of KSCST

The Chairman informed the members that with the assistance of KSCST Project Exhibition has been organised at VTU 'Jnana Sangama' Camus on 12<sup>th</sup> and 13<sup>th</sup> August 2022. VTU funded projects will also be exhibited in this exhibition. Hon'ble Minister for Higher Education will be gracing the inaugural programme.

#### Item No. 6.6 3<sup>rd</sup> Tech VCs' Conclave

The Chairman brought to the notice of the Members that VTU is organizing 3<sup>rd</sup> Tech VC's Conclave, in association with LIS Academy, Bangalore and MAP Systems, Bangalore, and some of the affiliated college and industry partners. Programmes will also be organized here to commemorate Azadi ka Amrit Mahotsav, Engineers' Day and the Silver Jubilee year of VTU. Hon'ble Governor of Karnataka the Chancellor of VTU is kind enough to be the Chief Guest for this programme which is being organized on 15<sup>th</sup> September 2022. The Chairman requested the members to be present for the programme.

#### Item No. 6.7 Grievance Redressal Cell

The Chairman expressed that University is planning to have VTU Grievance Redressal Cell with approved Regulations. Here the students, having any grievance, will have to approach to this Cell first and VTU will resolve their grievance as per University Regulations and Norms. It is felt that this approach will reduce the number of Court Cases. Hence, the Regulations to this effect are to be made at VTU.

#### The Executive Council approved the concept.

### Item No. 6.8 Role of University Nominees on various Committees of the Colleges

The members opined that the College should give minimum 15 days meeting notice to the VTU Nominees on recruitment committees/ Governing Councils, which is not being followed in many of the Autonomous Institutions. The Chairman expressed that unless the college has VTU Nominee invited on the meeting, and norms of TAAS are followed, these appointments will not be approved and such faculty will be treated as ad hoc employees.

# Item No. 6.9 Inviting Shri Vaju Bhai R Vala ji, Former Chancellor of VTU, to the inauguration of South-end block

The Chairman informed the members that the construction activities of South End Block of VTU Campus, which will be named as Silver Jubilee Block, is in its final stage and would be ready for inauguration shortly by the last week of August or little later. As informed earlier, University has extended invitation to Hon'ble Prime Minister of India Shri Narendra Modiji and other dignitaries of the State.

The members deliberated on the subject and suggested that the Former Governor of Karnataka, who was the then Chancellor, Shri Vajubhai R. Vala ji, who has guided VTU in several ways to take forward the said project, may be invited to the inaugural function.

The proposal was unanimously accepted at the Executive Council

### Granting benefit to the old students of VTU who could not complete the degree

The Chairman of the Executive Council informed the members that the Principal Secretary, Department of Higher Education, has suggested the University to consider the possibility of extending some benefit to the old students who could not get the degree in spite of completing the course duration, on account of failure in few subjects.

The members suggested that the current year being the Silver Jubilee year of VTU, VTU may consider such gesture for such candidates as a one-time measure, by granting additional attempts to clear the subjects and get the eligibility for award of the degree. The members noted that similar concession have been extended by few other Universities during their Silver / Golden Jubilee years.

#### **Resolution No.8.4**

After detailed deliberations on the subject, the Executive Council resolved to constitute a Committee, with Registrar (Evaluation) as Member Secretary, to look into this matter, and get a detailed report about the old students of VTU who could not complete their degree, and explore the possibilities of extending them some benefit, in the form of additional attempts. The detailed report shall be submitted to the Executive Council for further consideration and decision.
