

## ➤ **IMPORTANT DECISIONS OF THE EXECUTIVE COUNCIL DURING 2018-19:**

Important decisions taken by the Executive Council of the University in seven meetings held during from 1<sup>st</sup> April 2018 to 31<sup>st</sup> March 2019 are as under

### **140<sup>th</sup> Meeting of the Executive Council**

#### **Resolution No. 2.1.2**

The Executive Council resolved to approve the recommendation of the Academic Senate which recommended to issue “No Objection Certificate” for complete closure of Shri Pillappa College of Engineering, Bengaluru from the academic year 2018-19 and for the transfer of existing students to the non-autonomous colleges affiliated to the University, following the due procedures.

#### **Resolution No. 2.1.3**

The Executive Council resolved to approve the recommendations of the Academic Senate which recommended for the change of name of “M.S. Ramaiah Institute of Technology” to “Ramaiah Institute of Technology” along with the group Logo, subject to the approval of AICTE, New Delhi and State Government.

#### **Resolution No. 2.1.4**

#### **Resolution No. 8.3**

Executive Council resolved to approve establishment of Centre of Excellence in "Sustainable Petroleum Technology" by Rajiv Gandhi Institute of Petroleum Technology (RGIPT), Bengaluru at VTU PG Centre, Muddenhalli, Chickballapur Dist.

#### **Resolution No. 8.4**

The Executive Council resolved to extend the facility of parallel classes from 5<sup>th</sup> semester onwards to the students admitted during the academic year 2014-15 (admitted to 2010-11 scheme) who gain eligibility to join 5<sup>th</sup> semester during the year 2018-19.

The Executive Council further resolved to permit the student of all previous batches who gain eligibility to join 3<sup>rd</sup> / 4<sup>th</sup> semester level during 2018-19 to join the currently running scheme (2017-18 schemes).

#### **Resolution No. 8.5**

The Executive Council resolved to accept the recommendations of the committee which recommended to discontinue the transmission of VTU Educational programmes through EDUSAT, due to poor quality and financial implication for maintenance. Further, the Executive resolved to shift all the movable items at VTU studio, DESRT, Bengaluru to VTU e-Learning centre at Mysuru.

### **141<sup>th</sup> Meeting of the Executive Council**

#### **Resolution 1:**

The Executive Council resolved to the approve the recommendations of the Academic Senate which recommended as follows:

- 1) The Students of 2015 and 2017 Schemes and those who have switched to these schemes / switching to these schemes should not have more than 4 Fail Grades (F Grades pertaining to theory as well as Practical courses) at any point of time for admission to any higher odd semester.
- 2) For admission to 7<sup>th</sup> Semester B.E/B.Tech the students should have completed all the courses of first year.
- 3) For admission to 9<sup>th</sup> Semester B.Arch. the students should have completed all the courses of first year and second year.
- 4) In case, CGPA is less than 5.00 at the end of the B.E/B.Tech. programme, students are permitted to appear again for SEE in full or part of the corresponding previous semester theory course/s by rejecting the performance of them (other than internship, technical seminar, project and laboratories) for any number of times subject to the provision of maximum duration of the programme, to make up the CGPA greater than or equal to 5.00 for the award of degree.
- 5) In case, CGPA is less than 5.00 at the end of B.Arch . Programme, students are permitted to appear again for SEE in full or part of the corresponding previous semester course/s by rejecting the performance of them for any number of times subject to the provision of maximum duration of the programme, to make up the CGPA equal to or greater than 5.00 for the award of degree.
- 6) The faculty Advisor/ head of the Department shall mentor the students to register the courses to make up the CGPA equal to or great than 5.00.
- 7) The University examination in all the programmers of study shall be conducted at the end of each semester for all the semesters. The examination shall not be considered as overlapping if at all a student appears for examinations conducted in the morning and afternoon session. Further, the examinations shall not also be considered as overlapping if the same student appears for the next day's examinations.
- 8) Non- Credit Mandatory courses shall not be considered for vertical progression. However, they are to be complete for the award of the degree as per regulations.
- 9) The Faculty Advisor / Head of the Department shall advice the students to maintain a CGPA of 5.00 or greater than 5.00 at the end of each academic year.

- iii. To authorise the Hon'ble Vice Chancellor to fix the examination centres for such Students, as per as requirement.

The Executive Council resolved to accept the recommendations of the Academic Senate which recommended to issue 'No Objection Certificate' for the closure of Sri Vidya Vinayaka Institute of



Technology, Bengaluru from the academic year 2019-20, subject to the approval of the AICTE and State Government.

Further, the Executive Council resolved to accept the recommendations of the Academic Senate to re-allot the students of the said colleges to nearby colleges and to impose processing fees on the college for the closure as per VTU norms.

### **Resolution No. 2.1.3**

The Executive Council resolved to accept the recommendations of the Academic Senate which recommended to issue 'No Objection Certificate' for the progressive closure of the S J B Institute of Technology, Bengaluru for setting up of deemed-to-be-University, from the academic year 2020-21, subject to the approval of State Government, UGC, and AICTE.

### **Resolution No. 2.2.1**

The Executive Council deliberated on the subject in detail and reviewed the recommendations of the Academic Senate on the subject. The Executive Council resolved not to approve the change of nomenclature of "B.E.in Industrial and Production Engineering" to "B.E. in Mechanical Engineering (Production)", as proposed by Malnad College of Engineering, Hassan. The Executive Council opined that as the course is being conducted in many colleges under VTU, it is not feasible to change the course title.

### **Resolution No. 2.2.2.**

The Executive Council deliberated on the recommendation of the joint Board of studies meeting held on 29-12-2018 and reviewed the recommendations of the Academic Senate thereon.

Executive council resolved to approve the recommendations of the joint Board of studies with following observation:

Agenda No.6: Suggested to verify whether the M.Techprogramme Food Technology is already institute at VTU. If not, steps to be taken to institute the same. If the course already exists, the scheme and syllabus of the said course to be reviewed.

Table Agenda No.5: The Executive council suggested that in cases where both Supervisor and candidate belong to Engineering the degree be awarded under Engineering faculty. In case where either the Supervisor or candidate belongs to Science stream, degree be awarded under Science faculty, which is the existing policy.

### **Resolution No. 2.3.1**

The Executive Council deliberated in detail on the subject and reviewed the recommendations of the Academic Senate on this subject. The Executive Council resolved to permit Mr. B. M. Sagar, HOD, ISE, R. V. College of Engineering, Bengaluru, to pursue his Ph.Dprogramme under VTU. Further, resolved to withdraw his guide-ship for Ph.D candidate and permit these candidates to register under new Guide/s.

Further, Executive Council resolved to amend the clause in the Ph.D Regulations of VTU to the effect that Research student under VTU cannot be a Research Supervisor at the same time, since one cannot be an examiner and student of the University at the same time.

### **Resolution No. 2.4.1**

The Executive Council resolved to approve the recommendations of the Malpractice Cases Consideration Committee in its meeting held on 01-02-2019, as placed in the meeting.

The Executive Council noted that the number of Malpractice Cases registered during the Dec.2018/Jan.2019 Examinations of University, has decreased drastically and has come down to 84 only. Members lauded the efforts of University in bringing down the number of Malpractice Cases by deploying CCTV, Camera and also restricting the students by imposing the server punishment for such cases.

### **Resolution No. 8.1**

The Executive Council resolved to accept the proposal for the institute of “Smt. Jayalaxmi& Sri A.V. Dasappa Memorial Gold Medal” at VTU and approved to award the said Gold Medal to a Girl Student who secures highest Marks in aggregate in Mechanical Engineering Stream.
