The Finance Officer welcomed the Chairman and the members of the committee and accordingly discussion was held on the following.

1. Confirmation of the proceeding of the 84th finance committee meeting held on 05-09-2022.

The Proceeding of the 84th Finance committee along with the Action taken report was placed for approval.

Resolution: The committee read and confirmed the same.

2. Approval of the Financial Statements of the 2nd Quarter of 2022-23.

The Financial Statements of the 2nd Quarter of 2022-23 (July-22 to September-22) was placed for information.

As per the Financial Statement, the receipts for the 2nd quarter are Rs.41.36 crore and the expenditure is Rs.54.37 crore. There is an excess of expenditure of Rs..13.01 crore over receipts for the quarter ending on 30-09-2022. The total receipts from 01-04-2022 to 30-09-2022 are Rs.94.69 crore and total cumulative expenditure is Rs.84.23crore. The progressive decline in the receipts of VTU was once again highlighted to the committee. The Financial Statements consisting of the Balance Sheet, Income and Expenditure, Receipts and Payment as on 30-09-2022 was placed for approval.

Resolution: The committee approved the financial statements for the Second Quarter for the year 2022-23 and resolved to recommend the approval of the same to the Executive Council.

3. Approval of compliance to audit report of 2018-20.

The Audit report for the Year 2018-20 was received on 30-09-2022 from Additional Director Karnataka State Audit and Accounts Department, Regional Office, Belagavi. The Compliance for the same is placed for approval.

The Committee discussed the audit report and the related compliance in detail and made certain observations regarding some of the audit paras:

- (a) The amount pertaining to receipts has been placed under objection.
- (b) The differences between Financial Statements of Income and Expenditure and Receipt and Payment are held under objection.



- (c) Works under construction where payments have been made in the previous financial years are held under objection.
- (d) Advances paid and other related expenditure previously held under objection are once again reflected in the audit report, thereby inflating the total amount held under objection.
- (e) The report mentions Non-production of records when most records have been produced for audit as seen from records.

Hence, the Committee felt that these and other similar observations should be submitted to KSAAD for consideration and further necessary action.

Resolution: The Committee approved the compliance to audit report to be submitted to the Government, and recommended that a letter be written to KSAAD regarding the issues pertaining to amount held under objection, non-production of records and others despite availability of records regarding submission of documents to audit. Since this has also been observed previously, it was resolved to recommend the same to the Executive Council for approval.

4. Approval for Revised Rates of Remuneration for Examination Related Assignments.

The meeting of the Committee for the revision of remuneration for examination related assignments was held on 25-08-2022 at VTU, Belagavi. The proceeding recommended by the committee for revision of rates was enclosed and the same was placed for approval.
