


7.1.4 Water conservation facilities available in the Institution:

1. Rain Water Harvesting system provided at VTU, Jnana Sangama Belagavi

A. Side drains are situated all along the ring roads, which feed 17 number of recharge pits provided at specific points along the ring road within the campus to improve the groundwater table. Further, several trenches have been constructed within the campus to obstruct the runoff and stores water for recharging the groundwater. Regular maintenance of the conveyance system and recharge pits is carried out by the engineering section.




