5. Maintenance of water bodies and distribution system at VTU Jnana Sangama, campus Belagavi

The University has constructed Elevated Storage Reservoir (ESR) of 75,000 ltrs capacity and Ground storage Reservoir (GSR) of 3,00,000 capacity in the campus. The sources of water are Borewell, openwell and water supply from City Corporation. There are few water bodies and many tanks with the campus to for managing the water resources. The university has constructed a comprehensive water distribution system in the year 2009. The schematic figure of the water distribution system along with location of water bodies/tank are as shown in the figure below:

Operation and Maintenance:


- The maintenance of water distribution system, water bodies and water tanks are maintained by the Engineering section.
- The Engineer section has qualified engineers and well trained plumbers for maintenance of entire water distribution system. There are total four plumber for operating the distribution system and also responsible for minor repair works.
- The water tanks are being cleaned by specialized agency using men and machines by inviting quotations as per the schedule mentioned below:
 - o Hostels: Once in four months
 - o Quarters and Guest House: Once in Six Months
 - Over Head Tank and Underground Tank: Annually
 - o Fountain and water bodies: Once in Six months
