CIRCULAR

**Sub: Regularization of recommendations w.r.t affiliation
for the academic year 2018-2019 during LIC visits
for the academic year 2019-20 – reg....**

With reference to the above, every year University invites application for affiliation for Continuation / Extension of Affiliation, Variation in Intake of existing courses and Starting of New Courses for both UG and PG courses. After LIC visits and approval from the respective bodies of the University, the recommendation will be sent to AICTE and State Government. However, there may be difference in recommendation of VTU and AICTE / State Government for variation of Intake of existing courses and starting of New Courses (UG and PG for the academic year 2018-19).

Hence, to bring the uniformity in recommendation of AICTE/ State Government and VTU, the colleges have to apply for regularization, as per the enclosed format and fee details as follows.

	Fees in INR
1. Inspection fee for both UG/PG (If applied for Variation of Intake / Starting of new courses and not recommended by VTU for the academic year 2018-19)	: 1,00,000/-
2. New UG Courses (If not applied for starting of New Course for the academic year 2018-19, during regular application)	: 50,000/- per course
3. New PG Course (If not applied for starting of New Course for the academic year 2018-19, during regular application)	: 20,000/- per course [min. 40,000/-, upto 2 courses]
4. Increase in Intake (If not applied for Increase in Intake for the academic year 2018-19, during regular application)	: 30,000/- per course (UG/ PG)
5. Starting of New Engineering/ Architecture College (If not applied for the academic year 2018-19, during regular application)	: 3,00,000/- Engg. College 5,00,000/- Arch. College
6. Penalty Fee (If not applied for Variation of Intake/ Starting of New Courses for the academic year 2018-19, during regular application (Inspection fee : 25,000 & Penalty fee : 25,000)	: 25,000/-
