PROCEDURE FOR ONLINE FILING OF EXAMINATION APPLICATIONS:

- 1. URL: http://prexam.blr.vtu.ac.in for Bangalore Region (where the college code starts from A to M (For Ex: 1AA to 1MV)
- 2. URL: http://prexam.blr1.vtu.ac.in for Bangalore Region (where the college code starts from N to Y (For Ex: 1NH to 1YD)
- 3. URL: http://prexam.vtu.ac.in for Belagavi, Kalaburagi and Mysuru Region colleges.
- 4. Examination application form can be submitted through Departmental Login and Multiple login facility is provided.
- 5. Principals of respective institutions shall identify a coordinator for each branch to enter applications received from the students.
- 6. The coordinators shall follow the instructions issued in the User Manual available online.
- 7. After completion of data entry of examination application form, student must be given a print copy of the application which must be signed by the student and a copy of the same must be retained.
- 8. Any modification in the already submitted application can be done with the edit option before the last date.
- 9. If the submitted application is edited during the penalty period will attract penalty.

- 10. Requests for editing exam form after the closing date will attract additional penalty.
- 11. Applications submitted and every edit of application will be logged. Every request for change will be verified.
- 12. Student must be informed to verify subject codes, **backlog subjects**, electives and open electives before submitting the data.
- 13. If offered open elective subject is a core subject in the same branch, students are not permitted to register for such subject as an open elective.
- 14. In the past, there have been requests from colleges to enter data of exam forms previously submitted by the students. Principals must ensure that, data submitted by the students must be entered without fail.
- 15. Students must be instructed to necessarily obtain a print of the application, verify for correctness and sign the print copy.
- 16. The information in respect of Application Printouts, Report Generation, etc., are made available in the user manual.
- 17. Submission of Consolidated list and Fee to the University: The college shall take a report after the last date and submit the fee to the University through online Fee Payment option available at http://vtu.ac.in/online-fee-payment/. After making payment, receipt, report and consolidated list shall be submitted to the office of the undersigned on or before 20th November 2018 2018.

INSTRUCTIONS IN RESPECT OF OTES STUDENTS

- 1. For any reason no student shall be permitted to appear for more than one regular semester during Dec. 2018/Jan 2019 Examinations.
- 2. Students are required to appear for examinations sequentially.
- 3. If a candidate has already written 5th and 6th Semester examination with eligibility, he/she should get eligibility to appear for 7th semester examinations during Dec. 2018/Jan 2019. If not, he/she shall be permitted to appear only for backlog subjects.
- 4. If a student is eligible to appear for 5th Semester Examination now, he/she shall be permitted to appear only for 5th semester and backlog subjects of 3rd and 4th semester examinations during Dec. 2018/Jan 2019.
- 5. If a student is eligible to appear for 7th Semester Examination now, he/she shall be permitted to appear only for 7th semester and backlog subjects of 5th and 6th semester examinations during Dec. 2018/Jan 2019.
- 6. Students are permitted to appear for backlog subjects of lower semesters.
