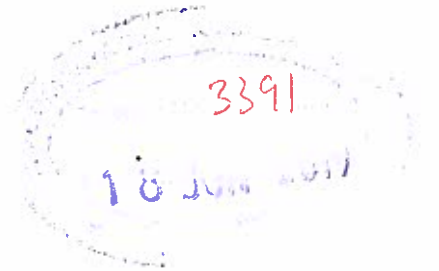


Sir/ Madam,

In continuation to this office letter of even number dated 11.01.2019 for compliance of the Hon^uorable Supreme Court orders in Writ Petition No. 292 of 2006, (instead of W.P No. 292 of 2008 due to typing error) UGC has decided the following actions to be taken by the Institutions immediately.

- Adoption and implementation of Harmonised Guidelines and Space Standards for Barrier free Built Environment for Persons with Disability and Elderly Persons, developed in February, 2016 by Ministry of Urban Development, Government of India, to make the existing buildings barrier free and accessible for Persons with Disabilities and the aforesaid guidelines shall also be followed during approval of the plan and Detailed Project Report in cases of new buildings.
- To form an Internal Committee comprising teachers, staff, students and parents for taking care of day to day needs of differently abled persons as well as for implementation of the schemes existing and to be devised in future.
- To report the proper functioning of Equal Opportunity Cell in the Colleges, Universities and other higher education institutions.

You are requested to implement the above mentioned recommendations in your University/ constituent and affiliated Colleges and furnish the action taken report to UGC at sectsectio@gmail.com within one month from the date of issuance of the letter.
