**Sub: APPLICATIONS / PROPOSALS TO BE FORWARDED
FROM VTU TO UGC with respect to 2(f) and 12(B)
OF UGC ACT 1956 - reg...**

The colleges who intent to apply for 2(f) and 12(b) status under UGC Act 1956 are hereby informed to note the following points.

Proposals for 2(f):

- 1.The Colleges are required to apply to VTU in triplicate (all three in original) of the proposal, properly bound with enclosures as prescribed by UGC.
2. Eligibility: Colleges affiliated to VTU.
3. The Processing fee of Rs. 5,000/- shall be paid online through the payment gateway and receipt of the same shall be enclosed with the proposal.

Proposals for 12(b):

- 1.The Colleges are required apply to VTU in triplicate (all three in original) of the proposal, properly bound with enclosures as prescribed by UGC.
- 2.The 12(b) proposals will be processed as per University norms / rules.
- 3.Eligibility : Colleges satisfying the clause 15(a) of Statutes on Permanent Affiliation of Colleges (Amended) 2011 (2015-16).
4. The Processing fee of Rs. 10,000/- shall be paid online through the payment gateway and receipt of the same shall be enclosed with the proposal.

Important Notes:

1. The colleges can apply for 2(f) and 12(b) simultaneously, however, separate applications are to be submitted along with processing fee as informed above.
2. The Colleges shall self assess themselves w.r.t. to all applicable norms of University and UGC before applying to University.
3. The incomplete proposals and proposals which do not fit in the norms will not be processed and no intimation will be sent to colleges in this regard.

4. Fees once paid will not be refunded or adjusted with any other fee payable to the University.
5. The Fee Certificate and Affiliation Certificate are to be submitted along with proposals only with requisite documents as required by the University The circular VTU/Aca/A-9/Circular/2018-19/9077 dt: 07-01-2019 and the content of undertaking are enclosed.
6. The Colleges which have already applied to VTU are required to resubmit their proposals as per this circular.
