#### **NOTIFICATION**

Whereas the draft of the Karnataka Selection of Candidates for Admission to Engineering, Medical, Dental and Indian System of Medicine and Homoeopathy Courses Rules, 2003 was published as required by subsection (1) of section 145 of the Karnataka Education Act, 1983 (Karnataka Act 1 of 1995) in Notification No: ED 102 TEC 2017, Dated: 06.05.2019 in part IV-A of the Karnataka Gazette Extraordinary dated: 11th July 2019, inviting objections and suggestions for the persons likely to be affected thereby and notice was given that the said rules will be taken in to consideration after 15 days from the date of its publication in the official gazette.

Whereas the said gazette was made available to public on 11th July 2019.

And whereas objection and suggestions have not been received.

Now, therefore in exercise of the powers conferred by section 14 of the Karnataka Educational Institutions (Prohibition of capitation fee) Act, 1984, (Karnataka Act 37 of 1984), and the section 145 of the Karnataka Educational Act, 1983 (Karnataka Act 1 of 1995), the Government of Karnataka hereby makes the following rules, namely;-

1. Title and Commencement: (1) These rules may be called the Karnataka Selection of candidates for Admission to Engineering, Medical, Dental and Indian system of Medicine and Homeopathy Courses (Amendment) Rules, 2019.

(2) They shall come into force from the date of their final publication in the official Gazette.

2. Amendment of Schedule-I:- In schedule-I to the Karnataka Selection of candidates for Admission to Engineering, Medical, Dental and Indian System of Medicine and Homeopathy Courses Rules, 2003, after serial number 13 and the entries relating thereto, the following shall be inserted, namely:-
