1. Two additional years are granted to the following students (to the batches given in the table) with the conditions given hereunder:
 - a) The students who have completed the course in full (attended all eight semesters examinations at least once) and appearing for their backlog subjects.
 - b) The students who have registered under One Time Exit Scheme (OTES) and completed the course work (attended classes of all eight semesters) are also permitted to appear for the regular semester examinations on attaining eligibility as per OTES Notification.
