Under the subject and reference read above, and as per the directions accorded from Ministry of Minority Affairs - Government of India , online applications are called for award of Post-matric and Merit-cum-Means Scholarship to the students belonging to the notified Minority communities of Karnataka viz., Muslims, Christians, Sikhs, Buddhists, Parsis and Jains pursuing PUC/equivalent, ITI, Diploma, Polytechnic, Professional and Technical courses at Undergraduate and Postgraduate level including M.Phil and P.hD from institutions recognised by appropriate authorities.

Accordingly, advertisements/notifications were given in leading newspapers calling for online applications (copies enclosed) and awareness is being created by using other suitable public media and also the detailed procedure as to “**How to apply for scholarship**” is uploaded on the Directorate’s official website:- <https://gokdom.kar.nic.in> or <https://scholarships.gov.in> or <https://dom.karnataka.gov.in>

As per the time line fixed by the Government of India, the last date for submission of online applications for both Fresh and Renewal scholarship is 30.10.2020.

According to the procedure designed under NSP, verification and online forwarding of students’ online registered applications by the institutions/colleges is mandatory. All the heads of the institutions/colleges are required to update their Institute details on NSP and add courses and fee structure

to facilitate the students to apply for scholarship (for such of those institutes who have not done this procedure last year) and also verify and forward the received online applications to the next level for sanction and release of scholarship amount to their students.

In view of this, it is hereby requested to issue directions to all your concerned officers/ Heads of colleges/Institutions under your purview to co-ordinate and co-operate in implementation of Government of India scholarship schemes in Karnataka. The Principals/Institution Heads may be intimated to follow the step by step operational manual for

- a) Adding of new Institutes and reset of login ID and password of already registered Institutes.(Formats are available on the Directorate of Minorities' official website:- <https://gokdom.kar.nic.in>)
- b) Procedure for updating profile of institutes in case of new institute additions.
- c) Updation of course level, courses and course fee.
- d) Verification of applications and forwarding the next level to the same (operational user manual enclosed for reference).
- e) Notification/Procedure (Copy enclosed).

To create awareness and to train the concerned officers and Head of Institutions workshops may please be arranged at Divisional Level or State level wherein Directorate of Minorities, Department of Minority welfare will extend its full support in giving training and presentations.

It is hoped that your good self will take immediate suitable action in this regard and intimate this to the Directorate to be prepared for imparting training or to give suitable material in implementing this scholarship scheme as it is a time bound programme.
