The following information is given as clarifications to the queries received from various colleges.

1. The list mentioned is the total list of the undergraduate (B.E.) programs under emerging / multidisciplinary areas announced in the AICTE approval process handbook 2021-22 (page no. 54 -56).
2. The list includes both **Instituted / not instituted** programs by VTU Belagavi
3. The listed programs are made available in the University Affiliation portal for all engineering colleges coming under the ambit of the University to opt for the new program to start from the academic year 2021-22.
4. Proposal for the start of the new program is required to submit as per the circular VTU/BGM/Academic/A12/2020-21/3694, dated 12.11.2020 to the university if the course is **not instituted** by University.
5. University will permit the increase in intake /additional course in Engineering and Technology only in **Emerging /Multidisciplinary Areas** provided, college needs to fulfill all the conditions mentioned in the clause no. 2.14 of AICTE approval process handbook 2021-22(page no. 54 -56).
6. Also, the university may reject the application - If the proposal is not as per circular VTU/BGM/Academic/A12/2020-21/3694, dated 12.11.2020
