With reference to the above, conditions laid down under the different heads of regulations governing various Postgraduate programs are relaxed and the students are permitted to seek admission to higher semester irrespective of number of backlog subjects from the academic year 2021-22 and onwards. The details are notified as under:

1. MBA/ M.Tech (Full time) / M.Arch. : The students are permitted to seek admission to 3rd semester if they have satisfied attendance and CIE requirements as per applicable regulations upto 2nd semester, with any number of backlogs courses from 1st and 2nd semesters.
2. MCA / M.Tech. (Part time)/ MCA (Lateral entry) :
 - a) The students are permitted to seek admission to 3rd semester if they have satisfied attendance requirements and CIE as per applicable regulations upto 2nd semester, with any number of backlogs courses from 1st and 2nd semesters.
 - b) The students are permitted to seek admission to 5th semester if they have satisfied attendance and CIE requirements as per applicable regulations upto 4th semester, with any number of backlogs courses from 1st to 4th semesters
3. Further, students must satisfy the CIE requirements of courses to appear for University examinations.
4. All the aforesaid relaxations are subjected to the permitted maximum duration of the programme.
