Some of the students of One Time Exit Scheme who have completed the B.E./B.Tech./ B.Arch./ programmes in full and failed to complete their degree have represented to the University. The said representations were placed before the authorities of the University and on the approval of Executive Council vide above reference, the following is notified:

Four consecutive additional attempts are granted to the students who have registered under One Time Exit Scheme (OTES) with the conditions given hereunder:

- a) The following students who have completed the course in full [i.e. attended course work of all **Eight** semesters (B.E./B.Tech.) / **Ten** semesters (B.Arch.)/ **Six** semesters (B.E./B.Tech. Lateral entry)].

- b) Students are permitted to appear for regular semester examinations sequentially irrespective number of backlog subjects
- c) Students are permitted to appear for backlog subject examinations, if any.
- d) Not permitted to appear for more than one regular semester examinations.
- e) If any student remain absent (for any reason) for any of the additional attempts as shown above, the same will be considered as an attempt
- f) Examination Fee to be paid: Rs 2,000/- per subject per examination to the maximum of Rs. 6,000/- per semester for the students appearing for examinations under the benefit of this notification.
- g) This benefit is not applicable to the students those who have not completed the course work in full.
- The Principals are requested to instruct the concerned to be more vigilant while submitting the applications of the students under the benefit of this notification.
