GENERAL INSTRUCTIONS TO COLLEGES

1. The college/department should file the application, this can be done in accordance with current practice. Uploading photo is compulsory.
2. **Strictly adhere to the Standard Operating Procedures issued by UGC, State Government and the University in the conduct of examinations.**
3. **The student must show a Government Photo ID card, such as Aadhar, Driving License or PAN card along with hall ticket for attending the exams. Further, the Chief Superintendent of the college/examination should identify that the right candidate is appearing for the examination.**

:PROCEDURE FOR ONLINE FILING OF EXAMINATION APPLICATIONS:

1. The user manual for the entire process is displayed in the departmental login/ student login .
2. URL: <https://prexam.vtu.ac.in> - for all colleges.
3. The applications shall be entered by one coordinator in each department using department login credentials.
4. The coordinators shall follow the instructions issued in the User Manual available online within the departmental login.
5. After approval from the college, the hall ticket will be generated on the given date.
6. The Coordinators should ensure the correctness of the information and upload the recent photograph of the student along with mobile numbers and email. The photograph should be a size less than 40KB.
