- **Examiner Allocation: Through Principal Login 30.01.2023**

Colleges are permitted to conduct the Internship Viva-Voce Examinations with internal and external examiner. The internal examiner is the internal guide of the student and external examiner is the external guide (Industry Expert) of the student. In case the industry expert is unable to attend, he may be substituted by a Senior Professor within the college/other college.

The appointment has to be made by the college Principal, the external examiner has to be appointed as Industry Practical examiner and the credentials available in a Principal Login has to be shared with the external examiner appointed.
