Candidates, Research Supervisor, and /or Co-Supervisor shall ensure that the application is filled in all respect and has at least one name of Research Supervisor and Research Co-Supervisor (if required), subject to availability of vacancy position (as per Table 1 under 20Ph.D. 7.3)

The University shall allot the Research center, Research Supervisor/Co-Supervisor based on the details submitted by the candidates and approval extended by the Research center, Research Supervisor/Co-Supervisor as per the University norms.
