- Subject:** ONLINE courses for PG programs(2022 scheme) regarding...
- Reference:** 2022 Scheme of Teaching and Examination and also draft regulation copy.

This is with reference to the subject cited above, there are two ONLINE courses suggested for PG students, one in 1st semester and another in 2nd semester. The following are the information brought to the notice of all concerned;

Audit Courses /Ability Enhancement Courses / Skill Enhancement Courses-Suggested by BOS (ONLINE courses):

Audit Courses: These are prerequisite courses for the program/s suggested by the concerned Board of Studies. **Ability Enhancement Courses / Skill Enhancement Courses** These are the courses suggested by the BoS, if prerequisite courses are not required for the programs.

Ability Enhancement Courses/ Skill Enhancement Courses: These courses are prescribed to help students to enhance their skills connected to the field of specialization as well as allied fields that lead to employable skills. Involving in learning such courses is the impetus for lifelong learning.

1. The courses under this category are online courses published in advance and approved by the concerned Board of Studies.
2. Registration for Audit /Ability Enhancement Course /Skill Enhancement Courses shall be done in consultation with the mentor and is compulsory during the concerned semester.
3. In case a candidate fails to appear for the proctored examination or fails to pass the selected online course, he/she can register and appear for the same course if offered during the next session or register and pass a new course offered during that session, in consultation with the mentor.
4. The Audit /Ability Enhancement Course/Skill Enhancement Courses carry no credit and are not counted for vertical progression. However, a pass in such a course/s is mandatory for the award of the degree.

5. The Online courses suggested should be other than the courses in the syllabus.
6. If suitable courses are not available in the BOS suggested list then, the mentor shall suggest the courses from the NPTEL list following rule no. 05. The mentor through the principal has to submit a request letter to the undersigned for the approval of the course (Prior approval is mandatory).
7. NPTEL publishes the courses list to be offered for January-June and July-December sessions of every year. University will publish BOS-selected NPTEL courses accordingly.

All the Principals of Engineering Colleges under the ambit of the University are hereby informed to bring the content of the circular to the notice of all concerned.
