: TEMPORARY AFFILIATION:

Applications are invited for :

a) Setting up the New Engineering / Architecture Institutions from the Societies/ Trusts registered under Society Registration Act 1860 and which have a Governing body (as per AICTE norms for 2023-24)*.

Applications are invited from the existing Institutions:

- b) for Continuation/ Extension of affiliation for B.E./B.Tech./B.Arch./B.Plan./B.Voc./ B.Sc./ MCA/ MBA/ M.Tech./ M.Arch./ M.Plan. Programmes.
- b) to start NEW-UG [B.E./B.Tech./B.Arch./B.Plan/ B.Voc.] and PG [MCA/ MBA/ M.Tech./ M.Arch. / M.Plan. programmemes (for the titles of the programmes which are already instituted and recognised by VTU) (as per AICTE norms for 2023-24) *.

*: Institutes are required to apply for No Objection Certificate (NOC) from University as well as apply through online affiliation portal. The applications for new programmes / variation in intake/ closure of

Programme of Institutes which do not get NOC from University shall not be processed / evaluated during LIC visit and subsequently new programme / increase in intake shall not be granted.

Please note that, variation in intake/ adding new programme will be permitted strictly adhering to AICTE norms. Hence, Colleges need to be cautious in this regard. Fees once paid to VTU will not be refunded / adjusted.

II] Vocational programmes in existing institutes [B.Voc.]:

II] UG programme in Kannada Medium:

Institutes can also apply for B.E. Programme in Kannada medium to AICTE. One such programme with an intake of 30 for each Institute will be considered strictly in accordance with prescribed AICTE norms and will be approved by the University based on AICTE approval.

: PERMANENT AFFILIATION :

: Fresh and Renewal:

Applications are invited from existing colleges for Permanent Affiliation as per the VTU Statutes on Permanent Affiliation of Colleges (Amended) 2011 (visit https://vtu.ac.in/pdf/affiliation/Permanent-Affiliation.pdf).

Compliance of following norms is mandatory for Permanent Affiliation:

- a) College should be recognized under 2(f) of UGC Act, 1956
- b) The programme for which permanent affiliation is sought
 - i) Should be temporarily affiliated by VTU for a minimum continuous period of five years
 - j) should have valid accreditation from NBA (as per Karnataka State Govt. Circular)

Autonomous Colleges:

- a) Every autonomous college, irrespective of whether applying or not, shall have to fill the affiliation application. The data submitted will be used for various other applications and for submission of statistical data
- b) If any variation in approval i.e. new programme, variation in intake, Autonomous fees structure is applicable including application fees and processing fees. (As notified VTU/BGM/Aca-OS-Cirs/2021-22/726 dt: 8-6-2021)

: RATIFICATION FOR THE ACADEMIC YEAR 2022-23:

Every year University invites application for affiliation for Continuation / Extension of Affiliation, Variation in Intake of existing courses and Starting of New Courses for both UG and PG courses. After LIC visits and approval from the respective bodies of the University, the recommendation will be sent to AICTE and State Government. However, there may be difference in the recommendation of VTU and AICTE / State Government for variation of Intake of existing courses and starting of New Courses (UG and PG for the academic year 2022-23).

Hence, to bring the uniformity in recommendation of AICTE/ State Government/ CoA and VTU, the colleges have to apply for ratification of such approvals which the Institute did not apply to VTU during 2022-23 or applied to VTU, but not recommended, however sanctioned by AICTE & appeared in Govt. Seat Matrix. The Colleges shall apply for ratification with applicable fee on affiliation portal (refer fee structure).

AICTE/ CoA approval letters, as applicable and Govt. Seat Matrix for 2022-23 has to be compulsorily uploaded on affiliation portal.

However, the inspection for these programme/s shall be made along with regular LIC visit for the academic year 2023-24. It is further informed that, if none of the programmes needs ratification, then ratification statement need not be filled.

: CLOSURE OF INSTITUTES:

Applications are also invited for progressive Closure (zero intake for first year and higher semester will continue) and Complete Closure of the Institutes (with transfer of all students). Such Colleges must comply the conditions prescribed by the University.

: RECOGNITION OF RESEARCH CENTRES :

STARTING OF NEW UG/PG PROGRAMMES UNDER EMERGING /MULTIDISCIPLINARY AREAS

The proposals for starting and instituting for new UG/PG program/s in **Emerging /Multidisciplimary Areas** are invited from the colleges that are planning to start during the ensuing AY 2023-24. AICTE has yet to publish the APH 2023-24, however, the college can refer to APH 2022-23 for the list of programs for UG/PG in the **Emerging /Multidisciplinary Areas**.

If the proposed program/s is not **instituted** under VTU, then the college has to submit the proposal for starting and instituting a new course as per the guideline mentioned below-

- Under Graduate and Post Graduate Programs shall confirm to the Nomenclature approved and listed in Approval Process handbook of AICTE
- 2. College wishes to start a new program with the title not listed in approved nomenclature of AICTE, have to apply to AICTE well in advance for approval of the nomenclature.
- 3. All proposals for the introduction of the new program shall (Detailed Project Report should)include
 - a. History-
 - 1. About College-name and address, Affiliation, Year of Establishment, Type of institute, NAAC status, NIRF ranking
 - 2. Detail about the program being offered,- Course, department, Programme started to date, AICTE approval year with intake, NBA status.
 - 3. Vision and Mission of the Institution
 - 4. Contact Details
 - b. Objective of the New program
 - c. Scope of the new program
 - d. Job opportunities for a new program
 - e. Appropriated survey report for the confirmation of all above points
 - f. Justification shall clearly specify how the existing (similar stream) program are not fulfilling manpower requirement.
 - g. Justification shall clearly specify how the new proposed program will be fulfilling man power requirements. (If colleges are running UG/PG program, the success of such program shall be considered for the award of the new program).
 - h. The proposal should agree with man power requirements as per AICTE norms.
 - i. A new program shall be proposed after a review of existing similar program/s and shall have not more than the 40% overlap of contents of courses.
 - j. New programs shall be considered preferably in the emerging area or in an interdisciplinary area.
 - k. PG programs shall be awarded to an institution if the corresponding UG program in the department is accredited.
 - Infrastructure facility details
 - 4. Proposal should contain **Syllabus**, **Scheme of Teaching and Examination**, as per University template. (please send request email for template/s to sbhvtuso@gmail.com)
 - 5. If College is Autonomous then, Regulation governing the UG/PG program should be enclosed in the proposal.
 - 6. For the UG program I & II semester common syllabus should be enclosed for reference.
