Sir,

You are aware that AICTE act 1987 was passed by the parliament. AICTE has been mandated to ensure qualitative improvement of Technical Education in India. Under the AICTE act 1987 it has been mandated to laydown norms & standards of technical education. It is mandatory for all the Institutions running technical courses to seek AICTE approval and adhere to norms & standards in respect of course curriculum, physical & infrastructure facilities, faculty qualification etc.

It is observed that large number of institutions in many States do not adhere to AICTE norms fully and have been found deficient in respect of infrastructure, faculty and many other areas. We, therefore, request your good office to direct the technical institutions under your jurisdiction to strictly follow the AICTE norms & guidelines. This will, certainly ensure improvement in quality of technical education in the State.

Further, there may be few institutions in your state running technical courses without AICTE approval. Whenever case of such unapproved Technical institutions comes to the notice of AICTE, name of such an unapproved institution are published in AICTE portal under the list of Unapproved institutions. As such Degree/Diploma/Certificates issued by such institutions are not valid. Such unapproved institutions must be directed by the State Government to seek AICTE approval to run the Technical programme/ course. In case of noncompliance, State Government must initiate action and ensure discontinuation of the technical courses by such unapproved institutes.

We are sure your intervention will go a long way in quality improvement in the State.
