GUIDELINES TO CONTRIBUTORS FOR CONFERENCE PAPERS/ CASE STUDIES

All papers will be evaluated through a double-blind review process by experts duly constituted from reputed universities / organisation / institutions in and outside India. Each contributor is required to submit double spaced copy of the full paper hard copy and soft copy and abstract of 300 words in MS word format in English in Times new Roman using 12 type font for consistency in A4 size setup with one inch margin all around and an abstract of not more than 300 words should be sent by 05th May 2023. Notification of acceptance of the paper will be done within one week from the date of submission and the full length paper should not exceed 3000 words and must be sent within a fortnight from the date of receipt of acceptance of the intimation from the organisers. The participants are requested to forward the abstracts and full paper mentioning the relevant track via soft copy at the following email ids: Only

Final paper submission must accompany a certificate by the authors that the paper is an original piece of their work and has neither been published nor submitted for publication elsewhere. Selected papers shall be published in leading journals of the country.

The cover page of the paper should contain the

i) Title of the paper

ii) Track in which the paper is to be included

iii) Name of the authors with their designation and professional affiliation

iv) Complete postal address with their email and contact numbers

Paper presentation will take place in concurrent sessions and the abstract of each accepted paper will be published in the conference proceedings.

BEST PAPER AWARD (S)

In each session/track three papers will be selected for the best paper award. Such authors and delegates whose papers are shortlisted for the best paper award will be given a certificate and an award and these selected papers shall be published in reputed journals of the country.

PRESENTATION OF PAPERS

Though the conference is to be held in hybrid mode participants shall be encouraged to physically present the papers however in exceptional cases participants may choose to present the paper online. An additional processing fee of Rs.500 /10 \$ shall be levied on people choosing to present their papers online.
