#### ELIGIBILITY CRITERIA FOR EMPANELMENT

Applications will be invited from reputed Publishers/ Distributors/ Vendors to seek empanelment as authorized vendor(s) for supply of printed books to the VTU Libraries for the financial years 2023-24, 2024-25 & 2025-26 and which may also be extended for two more years based on satisfactory services. The Publishers/ Distributors/ Vendors seeking for empanelment have to fulfill the following eligibility criteria:

- The vendor should be a registered member of registered national/ state trade federations like FPBAI, DSBPA, etc. Copy of Registration certificate must be enclosed with the proposal.
- The vendor should submit Permanent Account No. (PAN) issued by the Income Tax Department.
- The Distributors/ Vendors must submit their license of Import/Export Code (IEC) certificate issued by Ministry of Commerce, GOI, with the proposal.
- \* The wendor should have satisfactorily supplied books to at least any three Government Universities-Central/State in last Financial Year (satisfactory supply certificate along with order copies should be attached).
- \* The vendor should have a minimum annual Turnover of Rs. 200 Lakhs (Rupees Two Crore only) in last Financial Year 2022-23 (C.A. certificate should be attached).
- The vendor should have a minimum average annual turnover of Rs.100 Lakhs (Rupees one Crore only) in the last three (3) consecutive financial years (C.A. Certificate should be attached).
- The vendor is required to include a Purchase Order with a minimum value of Rs. 10,00,000 (Rupees Ten Lakh) for the supply of printed books to any Central/State



- ❖ The vendor should enclose ITRs for last 3 Assessment years along with photocopy of audited Balance Sheet duly certified by Chartered Accountant.
- The vendor should be a distributor/dealer/stockiest/executive/preferred agent of the publishers. Please submit the most recent authority letters issued by the publisher(s).
- ❖ The application is required to be accompanied with a DD of Rs. 10,000/- plus 18% GST (non-refundable) as Application fees in the favor of "Finance Officer, VTU, Belagavi, Karnataka"
- The vendor should also have to enclose a DD for Rs. 3,00,000/- (Rupees Three Lakh Only) in the form of Security Deposit in favor of "Finance Officer, VTU, Belagavi, Karnataka" which will be returned after satisfactory completion of the supply of books and expiry of the tenure. However, the Security Deposit would be forfeited if the selected bidder(s) fails to supply the ordered books satisfactorily, in the specified time. The Security Deposit of the unqualified bidders would be returned after the empanelment of other qualified firms. Security Deposit money will not entail any interest.


