The autonomous colleges shall also seek approval from Registrar (Eval.) VTU, if any of their student is availing such benefit:

- 1. Representing Country/State/University/Institution in VTU approved Sports and Cultural activities to the extent of actual days of the event + Journey days.
- Representing Country/State/University/Institution in NSS/NCC aches and Camps to the extent of actual days of the event + Journey days.
- 3. Representing contingents in Republic Day Parades to the extent of actual days of the event + Journey

Further, the Principals are also hereby informed to conduct the separate additional Internal Assessment Tests to such above referred students who are unable to attend the regular tests clashing on the days of above referred events.
