A. Statutory Requirements:

- d) IT returns for the past 3 years (Assessment year 2020-2021,2021-2022 and 2022-2023) and GST returns for the financial year 2019-2020,2020-21 and 2021-2022.

B) Technical requirements:

- 1. At least 3 years of experience / expertise in the successful execution of similar works tendered and the cost of such any one work should not be less than 50% of estimated Amount in a single tender in any State Central Governments or Quasi Government Department or Undertaking / Universities / Colleges.
