### Instructions to Research Scholars:

- 1. Research Scholars shall submit the applications to the Research center as per the mode of submission defined by the college.
- 2. Fee for Special Revaluation/Photocopy is mentioned below.
  - a. Fee for Revaluation is Rs. 10,000/- per subject.
  - b. Fee for Photocopy is Rs. 1,000/- per subject.
  - c. Application Fee of Rs. 30/- per candidate.
- 3. Research Scholars must pay the fees as per the instructions issued by the Research centers.

## INSTRUCTIONS TO COLLEGE STAFF ENTERING DATA;

- 1. Constantly monitor the applications received from the Research Scholars, maintain a list of all received applications and their status (data entry done/not done).
- 2. Research Scholars must pay the fee as per the instructions issued by the research center.
- 3. Research centers must ensure that each application is submitted online, in the VTU special revaluation application portal.
- 4. Take extra care when you enter the email ID and mobile number of Research Scholars. They will be required to verify the application data as well as receive photocopy. If there is a mistake in this entry, Research Scholars will not be able to receive photocopy.

They must all be numbered and filed so that they can be accessed later. They will be used as reference documents in case there are any complaints from Research Scholars.

- 6. Applications must be submitted as per the prevailing practice at the URL: https://prexam.vtu.ac.in printout of the applications must be taken and verified for its correctness and a copy of the same is to be sent to the Research Scholars.
- 7. It is the responsibility of the research centers to ensure the correctness of the data entered by the research center.
