With reference to the above subject and references, the following amendments are notified

Existing- 2018 Regulations		Amended- 2018 Regulations
180B 8.4	 (i) Students satisfying the attendance requirement but failing to secure the minimum percentage of CIE marks, in any Course/s, shall not be eligible for the SEE conducted by the University and they shall be considered as fail in that Course /those Courses. However, they can appear for University examinations conducted in other Courses of the same semester and backlog Course/s if any. (ii) Students who have satisfied the attendance requirement but not the CIE requirements shall be permitted to register afresh and appear for SEE after satisfying the CIE requirements in the same Course/s (with or without satisfying the attendance requirement) when offered during subsequent semester/s. (iii) Each appearance to SEE to complete a course shall be treated as an attempt. 	Students who have satisfied the attendance requirement but not the CIE requirements shall be permitted appear for SEE after satisfying the CIE requirements in the same Course/s immediately in the ensuing semester. No Change
180B9.4	A candidate, who does not satisfy the attendance requirement (in one or more Courses and including the Courses Additional Mathematics I and II) as mentioned in 180B 9.1 shall not be eligible to appear for the Semester End Examinations of that semester and shall not be permitted to take admission to next higher semester. The candidate shall be required to repeat that semester during	A candidate, who does not satisfy the attendance requirement (in one or more Courses and including the Courses Additional Mathematics I and II) as mentioned in 180B 9.1 shall not be permitted to appear for the SEE of these courses, however, he/she will be permitted appear for SEE for other courses of the same semester.

the subsequent year.	Registration for the courses with the shortage of attendance is permitted in the next immediate semester. The college must conduct parallel classes for such courses in addition to their regular semester sessions.
