3. The fee category will be the same for the students under which they have been admitted during I semester (regular) / III semester (lateral entry) students.
4. The other fee of the college shall be paid by the student at par with the regular students of that college.
5. The student shall be permitted to appear for the backlog papers in the allotted college, if any.
6. The students shall produce the Identity card or Exam Hall Ticket, CET/ Comed-K allotment letter, Receipt of fee paid (Proof of tuition & other fee paid).
