1) Eligibility Criteria:

A. Statutory Requirements:

- a) The Tenderer should furnish GST Registration Certificate.
- b) The Tenderer should have registered with the Municipal of Corporation/Registration of Societies/Companies/Director of industries and principal place of business of the Company or firm or partnership, as the case may be.
- c) PAN Card Photocopy
- d) IT returns for the past 3 years (Assessment year 2020-2021,2021-2022 and 2022-2023) and GST returns for the financial year 2019-2020,2020-21 and 2021-2022.

B) Technical requirements:

- 1.
