



She also explained the Objectives of the Women Cell-Internal Complaints Committee, which are as under:


Objectives of the cell:

- To take proactive measures to make workplace of the women safe.





Sexual harassment includes any one or more of the following unwelcome acts or behavior (whether directly or by implication)





Preventive measures against Sexual Harassment were also explained.



Complaint with the appropriate authority, disciplinary action against Harassment and Complaint mechanism for Redressal made by the victim was explained.

Complaint Mechanism (Inquiry)





Creating an environment where everyone feels safe, valued and empowered was emphasized and adequate measures to be taken to create an environment for women employees and girl students that is free from violence, women harassment, discrimination and one that promotes exposure to self-esteem, self-efficiency development and secure environment by creating awareness about their rights.

The program ended by the Resource Person reminding the students to be confident and trust once own instinct.

A large number of girl students were present and received the benefit of the matter discussed.





