With reference to the above subject, it has already been informed to all college to obtain VTU nominee for selection committee and obtain approval of the University for the Appointments. Despite of repeated directions, it has been observed by the University that the same has not been followed by a few colleges.

Hence, the following is informed:

1. The Principal/ Director shall be appointed meticulously following the AICTE qualifications and procedure as set by University.
2. The appointment of Principal/ Director shall be approved by the Governing Council of the respective college.
3. The Principal/ Director without satisfying AICTE Qualification and / or VTU procedure (as applicable) , will not be consider as a valid appointment. The same will be reflected in LIC report.
4. Further, the day to today communications sent by such (invalid appointment) Principal/ Director will not be considered/ entertained by the University.
5. It may also be noted that the University may initiate action against such erring colleges.
