- Readmission fees: Rs. 5,000/- for each student. Late fees of Rs. 5,000/-
- Fee shall be paid through online (please visit www.vtu.ac.in). **Fees once paid is non-refundable.**
- Incomplete applications & applications received without prescribed fee will not be processed by the University & no communication shall be sent to colleges in this regard.
- The applications shall be submitted through post/courier
- No individual student / parent/ guardian shall be sent to the University.
- Please Note :** a) while forwarding the readmission applications , the Principals of Colleges are informed to refer all the applicable University Regulations , notifications, circulars etc and only after confirming the compliance to these, the applications shall be forwarded. Any lapse or wrong applications, the Principals of the respective colleges will be held responsible . b) Principals have take due care with respect scheme of study of the readmitting students. c) Parallel scheme : Classes shall be conducted on fast track basis to complete the syllabus and to meet the Examinations schedule of the University
