Subject: MOOCs(Online Courses completion for PG students 2023-24 admitted batch regarding...

The students admitted to 1st semester postgraduate programs in the academic year 2023-24 have to complete MOOCs (NPTEL) courses as per the scheme before the completion of the degree program. The following are the few guidelines given for the students to follow while completing the course.

- 1) For PG programs students, BOS-suggested ONLINE courses will be made available @<https://online.vtu.ac.in/>
- 2) These courses list will be added with the new courses every session as and when NPTEL publishes the list of new/updated courses (every Jan-April session / July-Oct session).
- 3) The courses under this category are online courses published in advance and approved by the concerned Board of Studies.
- 4) The students have to select the courses for study and pass that suggested by their Board of Studies (disciplinary or interdisciplinary)
- 5) Registration to this ONLINE (NPTEL) Course shall be done in consultation with the mentor and compulsory during the semester.
- 6) In case a candidate fails to appear for the proctored examination or fails to pass the selected online course, he/she shall register and appear for the same course if offered during the next session or register for a new course offered during that session, in consultation with the mentor.
- 7) The Ability Enhancement /skill Enhancement Course carries no credit and is not counted for **vertical progression**. However, a pass in such a course is mandatory for the award of the degree.

- 8) College has to submit the program-wise, course registration details of the students to the university.
- 9) The students want to enroll in a course or courses other than those that the Board of Studies has specified, but they discover that the content of those courses does not align with those in their program of study. However, he or she must request approval for the chosen courses from the University through the mentor, program coordinator, and principal.
- 10) M.Tech., M.Arch., M.Plan, and M.Sc(Chemistry), students have to complete a total of two such courses, whereas, MCA students have to complete one online course to get eligibility for the award of the degree. (Each course should be of a minimum of 08 weeks duration. However, students can take two 04-week duration courses instead of one of 08 weeks duration courses).
- 11) Registration for the PG online courses is free and compulsory. Students are advised to follow the following procedure for registration.
 - Go to <https://online.vtu.ac.in/>
 - Click on the sign-in button in top right corner
 - If you are a new user, click on Create an account
 - Fill your email, phone number, and name, and create a new password.
 - Click sign-up and enter the OTP
 - Log in by entering your email ID and password
 - You will be taken to the student's dashboard, click on the Academics in the top right corner
 - Then click for the apply for PG MOOCs courses
 - Fill the details and submit the form
 - For any clarification related to registration write an email to -prkruthiso23@gmail.com
- 12) Students have to select the courses whose content is not mapped with any of the courses from the curriculum(syllabus) of study. Take the advice of the coordinator/mentor while selecting the courses.
