A. Statutory Requirements:

- d) IT returns for the past 3 years (Assessment year–2021-2022,2022-2023 and 2023-24 GST returns for the financial year 2020-21, 2021-22 and 2022-2023.

B) Technical requirements:

1. At least 3 years of experience / expertise in the successful execution of similar works tendered and the cost of such any one work should not be less than 50% of estimated Amount in a single tender in any State Central Governments or Quasi Government Department or Undertaking / Universities / Colleges.
