This notice is to inform all students regarding the subject cited above. As per the recommendations of the joint Board of Studies, which were approved in the 178th EC meeting of the university, students who were previously registered for the old scheme subjects must now appear for the examinations of the newly suggested equivalent subjects. The list of equivalent subjects is available and has been notified at https://vtu.ac.in/en/course-subject-equivalences/.

Based on the available data on BACKLOG subjects:

- 1. In the 2018 scheme column, the equivalence subjects for old schemes (2004, 2010, 2014, 2015, 2017, etc.) are listed.
- 2. In the 2022 scheme column, the equivalent subjects for the 2021 scheme subjects are listed.
- 3. In the 2018–2022 scheme columns, either a subject code or a code with a subject name is mentioned.
- 4. If equivalent subjects are not available, it is indicated in the 2018/2022 column as NO MAPPING / NO EQUIVALENCE.

Old scheme students (includes the students permitted to appear for two more attempt under silver Jubilee celebrations to clear their backlogs to complete their degree) must refer to and study the equivalent subject syllabus mentioned in the 2018 scheme to appear in upcoming examinations. Similarly, 2021 scheme students must refer to and study the syllabus of the equivalent subject listed in the 2022 scheme column for their upcoming examinations. If NO MAPPING or NO EQUIVALENCE is indicated, students must appear for their old scheme subjects during the examination.

For the issue of the hall ticket the students have to submit the UNDERTAKING form duly signed and endorsed by the Principal of the Institute. The format of the undertaking form is shown in the ANNEXURE-I attached with this notification.

Please note that the examination time table and other related notifications will be notified by the Registrar (Evaluation), VTU Belagavi. If any of the subject of old scheme is not listed, to update the same write the email to arun.rotti@vtu.ac.in / sbhalbhavi@vtu.ac.in.
