- c. Principals of respective institutions shall identify coordinators to enter applications received from the students.
- d. The Coordinators shall follow the instructions issued in the User Manual available online within the departmental login.
- e. The college must obtain the details of student including photo, email id, mobile number etc., and subjects to be applied signed by the student received through email or any other mode and the photo of the student must be uploaded.

CONDUCT OF EXAMINATIONS
