		2) Case 2: Students admitted to 2022 scheme in previous academic year/s and are not promoted to the 3rd semester due to their backlog subjects totaling to more than 16 credits, until the student obtain eligibility to 3 rd semester. 02	After their 4 th semester for F grade subjects of 3 rd and 4 th semesters only	Case 1: Students who studied 3 rd / 4 th semester in the same academic year and have met attendance and CIE requirements but have F grades in SEE. Note: The students who are in 2 nd year are not permitted to appear for their backlog subjects of 1 st and 2 nd semesters, if any, in supplementary/make up examinations.

03	After their 6 th semester for F grade subjects of 5 th and 6 th semesters only	Case 1: Students who studied 5 th / 6 th semester in the same academic year and have met attendance and CIE requirements but have F grades in SEE.
		Note : The students who are in 3^{rd} year are not permitted to appear for their backlog subjects of 1^{st} , 2^{nd} , 3^{rd} and 4^{th} semesters if any, in supplementary/make up examinations.
