With reference to the above subject, Research and Publication Ethics (RPE) Coursework for the research scholars who have registered for the Ph.D.(Part-Time/Full Time)/M.S.(Research)-program.

Further, all the provisionally registered scholars have to register for the course "Research and Publication Ethics (RPE-20RPE000)," which will be conducted by the university in a blended mode. Research students must register for the online course for RPE by paying the registration fee of Rs. 800/-. This amount has to be paid to VTU, directly by using online mode through the gateway by using their respective login credentials: <https://jnanashodha.vtu.ac.in>.

The research scholars (USN: XX20XX, XX21XX, and XX22XX) have to register for "Research and Publication Ethics (RPE)" on or before 01-10-2024 and for remaining coursework subjects the detailed time-table will be notified


