

PROCEDURE FOR ONLINE FILING OF EXAMINATION APPLICATIONS

1. User manual for the entire process is displayed in the College departmental login.
2. URL : **https://prexam.vtu.ac.in**
3. Principals of respective institutions shall identify coordinators to enter applications received from the students.
4. The Coordinators shall follow the instructions issued in the User Manual available online within the departmental login.
5. The college must obtain the details of student including photo, email id, mobile number etc., and subjects to be applied signed by the student received through email or any other mode and the photo of the student must be uploaded.


Instructions to the colleges/students:

- a. The makeup examination facility shall be available to those students who have appeared and failed in the SEE in one or more course in a semester. However, the students passing the makeup examination shall **lose their eligibility** to be considered for the **award of Ranks**.
- b. If a student has satisfactory attendance in a course and has secured a minimum of 40% in CIE but could not appear in SEE for valid and convincing reasons as specified under 220B3.7.1, shall be eligible to appear for the makeup examination, after due recommendation by the Principal/Dean and approval from the University.
- c. The following may be considered as other valid reasons for the semester-end-make-up examination:
 - Serious Illness / personal accident in the case of the student himself.
 - Serious Illness / Accident / Death of Parent /Guardian.
- d. The Makeup examinations for both semesters shall be conducted once a year at the end of the even semester.
- e. Students having "F" grades for courses totalling more than 16 credits in the 1st and 2nd semesters of the first year (who are not eligible to take admission to 3rd semester) are also permitted to appear for the MAKE-UP examination.
- f. The students who are not eligible for SEE due to a shortage of attendance or due to less than 40% marks in CIE are not eligible to take up the makeup examination.
- g. No revaluation provision will be made for students who are taking the Makeup examination.
- h. As per prevailing regulations for B.E./B.Tech., program Make-Up examination is applicable only for 2022 scheme applicable batches.
