## Short Term Tender Notification –Two Cover System- (e-Procurement Only)

1. The e-tenders (Two-Cover System) are invited induplicate from eligible tenderers, Registered Contractor, by the Registrar, Visvesvaraya Technological University, "Jnana Sangama", Belagavi-18, for the following work detailed in the table below under standard tender document procedure KW & KG format.
